








Background to the ACT Framework

- Developed by UNICEF and UNFPA Joint Programme for the Elimination of Female Genital Mutilation
- Limited availability of resources to track and monitor social norms change, and link any change to programmatic interventions
- Need for an evidence-based tool to help track social norms change in a standardized way
 - → At the same time practical, adaptable and applicable to different context



What is the ACT Framework?

- A Conceptual Framework to guide the measurement of FGM related social norms change
- A list of indicators to assess effectiveness of communication interventions
- A set of tools (structured interviews, focus group discussions and in-depth interviews utilizing participatory research methods)
- Guidance on "how" the framework should be implemented at the ground level, and accompanying templates

 Identify networks contacts whose opinion on FGM matters to them


Interview 3 influentials and 3 social network contacts



...about how many girls 10-14 years in your community are currently cut?


...about how many girls 15-17 years in your community are currently cut?

Do you think your immediate family expects you to continue or abandon FGM?




Average number of social sanctions associated with abandoning FGM


N.13 In your opinion, what are the social sanctions (punishments) associated with abandoning FGM?








